**Invitation for Expression of Interest:
Postdoctoral/Research Assignment "Studies of biomass burning emissions in the laboratory and the field"**

The Institute of Chemical Engineering Sciences, Foundation of Research and Technology - Hellas, (FORTH/ICE-HT) is seeking applicants for one postdoctoral/research assignment in the context of the research project "Pyrogenic Transformations Affecting Climate and Health (PyroTRACH)", which is implemented under the H2020-EU.1.1. - EXCELLENT SCIENCE - European Research Council (ERC).

Job Description

To conduct research in the framework of the aforementioned project "PyroTRACH". The main objective of PyroTRACH is to quantify the evolution of biomass burning emissions in the atmosphere together with their impacts on human health and climate.

Location: FORTH/ICE-HT, Patras, Greece

Duration: 12 months with the potential of renewal

Salary: 3.100 Euros per month (total cost of the employer, including social security and taxes)

A PhD in Chemical Engineering or Environmental Sciences on the topic of atmospheric aerosols or atmospheric chemistry is preferred. The candidates must be fluent in English. The evaluation of the candidacies will be based on the following criteria and qualifications:
