Invitation for Expression of Interest:

MSc Fellowship “Synthesis of carbon-based nanostructures and evaluation using surface sensitive techniques for energy storage devices”

The Institute of Chemical Engineering Sciences, Foundation of Research and Technology - Hellas, (FORTH/ICE-HT) is seeking applicants for one MSc fellowship position in the context of the research project “Integrating novel materials with scalable processes for safer and recyclable Li-ion batteries”, INERRANT, GA: 101147457, which is implemented under the Horizon Europe.

Job Description

To conduct research as a MSc candidate in the framework of the aforementioned project “INERRANT”. The main objective of INERRANT is to develop safe-and-sustainable-by-design materials, e.g. through the use of laser processing of raw materials, to ensure the economical and widespread utilization of safer LIBs in modern society. To realize this, INERRANT formulates a holistic approach to enhance safety, boost performance and improve fast charging, of Gen 3 LIBs tailored for mobility applications. The selected candidate will conduct research, as a graduate student (MSc), in the framework of the aforementioned project “INERRANT”, in the synthesis of carbon-based nanostructures and evaluation using surface sensitive techniques for energy storage devices.

Location: FORTH/ICE-HT, Patras, Greece

Duration: up to 6 months, with the potential of renewal or extension according to the needs of the project.

Fellowship: up to approximately 650 € per month (graduate fellowship) depending on qualifications.

Envisaged starting date: 01/12/2024

Requirements and Qualifications

The applicant should hold BSc in Physics or Chemistry or Materials Science or relevant field. The candidate should have been registered as a Graduate student (MSc) in a Materials Science Programme in a Physics or Chemistry or Materials Science Department or related discipline. Experience with evaluation of graphene-based nanostructures for energy storage devices, using surface sensitive techniques, would be strongly favored. Candidates must be fluent in Greek language and have a good knowledge of English (at least level B2) language.
