PhD fellowship “Optimization of plasma processes for water disinfection”**

The Institute of Chemical Engineering Sciences, Foundation of Research and Technology - Hellas, (FORTH/ICE-HT) is seeking applicants for one PhD candidate position in the context of the research project «Comprehensive and sustainable solution to minimize food loss and waste and promoting food security in the Mediterranean region», acronym: FUSION, GA: 2431, which is implemented under the “Mediterranean Area Programme (PRIMA)” supported by the European Union’s Horizon 2020 research and innovation programme».

**Job Description**

To conduct research as a PhD candidate in the framework of the aforementioned project “FUSION”. The main objective of FUSION is “Optimization of plasma processes for water disinfection”.

**Duration:** up to 6 months, with the potential of renewal or extension according to the needs of the project.

The applicant should hold undergraduate BSc in Natural Sciences or Diploma in Engineering Sciences and have been registered as a PhD Candidate in Natural Sciences or Engineering. Experience with cold plasma technology is strongly favored. Candidates must have good knowledge of the Greek and English (at least level C1) language.
