# Invitation for Expression of Interest: MSc Fellowship "Laser-engineered electrodes for energy conversion devices"

The Institute of Chemical Engineering Sciences, Foundation for Research and Technology - Hellas, (FORTH/ICE-HT) is seeking applicants for one MSc fellowship position in the context of the research project "Integrating novel materials with scalable processes for safer and recyclable Li-ioN baTteries", INERRANT, GA: 101147457, which is implemented under the Horizon Europe.

## **Job Description**

To conduct research as MSc candidate in the framework of the aforementioned project "INERRANT". The main objective of INERRANT is to develop safe-and-sustainable-by-design materials, e.g. through the use of laser processing of raw materials, to ensure the economical and widespread utilization of safer LIBs in modern society. To realize this, INERRANT formulates a holistic approach to enhance safety, boost performance and improve fast charging, of Gen 3 LIBs tailored for mobility applications. The selected candidate will conduct research, in the framework of the aforementioned project "INERRANT", in the preparation of electrochemical storage devices (batteries) based on graphene and its hybrid nanostructures produced using laser sources.

## **Requirements and Qualifications**

The applicant should have a BSc in Physics or Chemistry or Materials Science or relevant field. The candidate should have been registered as a graduate student (MSc) in a materials science program at a department of Physics or Chemistry or Materials Science or related discipline. Experience in the synthesis of energy related materials and characterization of relevant energy conversion devices is highly required. Candidates must be fluent in Greek and have a good knowledge of English (at least B2 level).
