Postdoctoral Research Assignment "Coordination of research for the study of the biomass burning emissions, their atmospheric chemical aging and effects on health and climate"

The Institute of Chemical Engineering Sciences, Foundation of Research and Technology - Hellas, (FORTH/ICE-HT) is seeking applicants for one postdoctoral research assignment in the context of the research project "Pyrogenic Transformations Affecting Climate and Health", Grant Agreement number: 726165 — PyroTRACH — ERC-2016-COG, which is implemented under the H2020-EU.1.1. - EXCELLENT SCIENCE - European Research Council (ERC).

Job Description

To conduct research under a work assignment or a fixed-term employment contract in the framework of the aforementioned project "PyroTRACH". The main objective of PyroTRACH is to quantify the evolution of biomass burning emissions in the atmosphere together with their impacts on human health and climate. The objective of this position is to coordinate research for the study of the biomass burning emissions, their atmospheric chemical aging and effects on health and climate.

Location: FORTH/ICE-HT, Patras, Greece

Duration: up to 6 months with the potential of renewal or extension according to the needs of the project

Salary: up to approximately 2.500 € per month depending on qualifications (total cost of the employer, including social security and taxes)

Envisaged starting date: 1/12/2022

Requirements and Qualifications

A PhD in Chemical Engineering or Environmental Engineering or Civil Engineering or Environmental Sciences or Environmental Management is preferred. Candidates must be fluent in Greek language and have a good knowledge of English (level B2) language.

Any application received after the deadline will not be considered for the selection.

Applications that are received on time will be evaluated by a scientific committee using the criteria mentioned above. If necessary, certain candidates will be invited to a personal interview with the committee.

Interview Criteria:

(a) Background in the objective of the assignment (5 points). (b) Organizational and communication skills (5 points). (c) Team-spirit and self-motivation (5 points). (d) Commitment to achieving the goals (5 points)
